NEW FOR THIS YEAR: Please register through the RAMP program as noted above. Given some of the uncertainties of this year, we have decided that rather than collect all fees upfront only to have to refund if by chance the season does not happen, we would have all families sign up through the RAMP system (which is usually step 2) and than once we know where things are at, prior to the first practices, we'll have the payment portion of registrations set up.

For returning families, you do not need to input all the information you had to last year, once you log in, you can register your child (which takes about 30 seconds!)


NEW THIS YEAR: There is a coach registration now. For those interested in coaching at any level, please register yourself as a coach!



FOR NEW REGISTRANTS WHO HAVE NOT SIGNED UP FOR RAMP YET:

This will take you to the Baseball Manitoba Interface for LaBroquerie Ball. You will need to create an account. Once created, login to the system and you should see a box to select "PARTICIPANT REGISTRATION" Please select that orange box and you should see this:




From here you will need to "add a family member". Please add all kids you may have in our program (it will ask for their birthdates and what division they are in)



You Will need to add parent information for each of your kids as the parent has to sign the "waiver" at the end consenting to Registrations. Once you have entered in your participant information and selected a "Division" you need to "purchase a package" (Please note, there is no cost to purchase this package). It will look like this (with the option to "purchase") Click on the check box and click "CONTINUE":



From here you will go through the Waivers and Consents including the Code's of Conduct. Accept all, and you have to (not very easily) sign your name in the box using your mouse, or finger if you have a touch screen.



Before you can finalize your registration, there are a few check boxes with respect to family heritage (for purposes of the JCC Maccabi Games or North American Indigenous Games eligibility). And you can finalize registrations! You will receive an email to the address you have inserted that confirms success of your registration, and it will also state that on the final page once you've registered. You have to register for all of your family members!
